8. Dimension corrected to match Metro's demolition of the east edge of the Main Parking Lot pavement.

Drawing revisions:

- 1) Changed the dimension from the Sidewalk Easement to the back of curb to 7'-4" on 1AS1.04 (Metro was to demolish 8'-0", allowing 8" for proposed curb width shown in Civil detail). Dimensions for the three adjacent parking spaces at the north end clarified.

9. Remove 5 proposed trees and all planting and irrigation from the area directly between HISD's temporary buildings and the HISD parking lot so area can be utilized by HISD.

- 1) Deleted the 5 northernmost Drake Elms (DE) along the main walkway from A1LP4.01;
- 2) Reduced the quantity of DE accordingly from C4LP4.01 Plant Schedule.

10. Add hand watering by portable water tank for the 22 trees to be transplanted to the area west of the West Service Road that is not tied to irrigation system. Hand watering for these trees is to be included in the one year landscape maintenance plan.
